#### CDP Scheme No.1

1.	Name of the Programme	Onfarm training to new Sericulturists (5 days)
2.	Duration of the programme / scheme	2005-06
3.	Objective of the programme	To help the new farmers to take up sericulture on scientific lines and equip them with essential basic tools.
4.	Physical and Financial targets of the programme	<u>Physical</u> : 500 Farmers <u>Financial</u> : CST+State = Total Per bene. 750 - 750/- Total Rs.3.75 Lakhs=Rs.3.75 la.
5.	Eligibility of Beneficiary	Farmers who planted high yielding mulberry during 2005-06.
6.	Pre-requisites for the benefit	i) The identified beneficiary must have minimum 1 acre mulberry garden.
7.	Criteria for deciding eligibility.	ii) He should rear Bivoltine crops. iii) The Beneficiary should undergo training at Govt. Sericulture Training Institute, Hosur.

## **Chapter - 14**

### **Particulars of Licenses granted by this Department**

- 1) Licenses are granted to the private seed producers based on their vehicle and financial eligibility.
- 2) Licenses are issued to these persons who are reeling silks from the cocoons through China, basin, Semi Automatic and Automatic Reeling machineries.
